# SITE DESCRIPTION AND LOCATION

## THE EAST RENFREWSHIRE GOLF CLUB, PILMUIR, NEWTON MEARNS, GLASGOW G77 6RT

The Proposed development is located at the The East Renfrewshire Golf Club just off Ayr Road, South of the Glasgow suburb of Newton Mearns.

In terms of the golf course itself, development will be located on the existing practice ground to the North of the club house where a new driving range will be built and installed. Additionally, further development will occur on holes 17 and 18 to the immediate West of the club house.






# PROPOSED DEVELOPMENT

The proposed option at this stage of the design development comprises the reprofiling of the existing course.

Works will include the importing of clean inert soils to raise current ground levels to create a new, high-quality driving range as well as improving holes 17 and 18.

This work will be completed alongside relevant drainage and landscaping works which will include the creation of a new pond, the realignment of a stream and the removal and planting of trees.
